## 2022-2023 Proposed Budget

# Superintendent's Message on Behalf of the Unatego Board of Education

As I write this message, I look back on how far we have come since March 2020. Compared to the past two school years, 2021-2022 was a return to "near-normal." Other than a couple of days of fully remote operation, we were able to stay open for full-time in-person instruction all year. We had concerts, musicals, and full seasons of interscholastic athletics culminating in a MAC first—League Championships in the same season for both our Boys' and Girls' Basketball teams. Although we continue to employ layered mitigations to reduce the risk of in-school COVID exposure, we are planning on finishing this year as close to "normal" as possible, with our students looking forward to year-end events like field trips, concerts, the prom, and graduation. We are also looking forward to the start of the recently approved capital project.

We are truly grateful to the district voters for their support of the much-needed project last May and although at this time we are still awaiting final approval from the State Education Department, teams from the school have been meeting with architects and engineers regularly since last summer to finalize the scope and timing of construction over the next several years. All necessary paperwork and drawings for Phase One of the project have been submitted to the State Education Department, and we are awaiting approval which is expected sometime in June. Phase I work includes major renovations to the Jr-Sr High School Auditorium and locker rooms, new high-efficiency propane boilers and HVAC systems, and improvements to the athletic fields. Electrical and plumbing upgrades will be completed at Unatego Elementary, and a new lift installed at the Bus Garage. We are hoping to start some work in August 2022 and hope to have Phase I completed by the fall of 2023.

We remain committed to providing our students with a first-rate education while keeping costs to the community as low as possible. Although the abovementioned capital project will be completed at no local cost, many other expenses continue to rise. As I write this, inflation is running near 9% annually, and costs related to school operation are up substantially. Energy costs, particularly fuel oil, gasoline, and diesel fuel are rising, as are materials and supplies; health insurance costs are also up significantly. After three years of zero or near zero tax increases, we are asking voters to approve a budget for the school year with a 1.48% increase in the tax levy (well under our 2.7% cap) to help us meet our rising costs.

Please come out and vote on the 2022-23 school year budget and for a candidate to fill a school board seat on May 17th from noon until 9:00 p.m. at the District Office, located at the Jr-Sr High School. Administrative: The Administrative component of the budget includes expenditures for central administrative and support salaries and related costs, Board of Education expenses, legal expenses, business office expenses, and insurance.

**Program:** The program component of the budget includes expenses relating to instruction, including salaries, benefits, textbooks, supplies, transportation, and athletics.

Capital: The Capital component of the budget includes custodial salaries and benefits, building maintenence costs and debt service costs.

#### DISTRICT'S BOND RATING UPGRADED BY STANDARD AND POORS

Earlier this year, S&P Global Ratings issued a report announcing that the district's long-term and underlying bond rating was raised from A- to A.

According to the report, S&P recognized that the district had made meaningful positive changes after several years of negative operational results and excessive use of fund balance; these included conservative budgeting and closing a building. These changes resulted in successful positive operating results over the last five years which saw an increase in the district's available reserves.

The district's financial advisor, R.G. Timbs, Inc., estimated that the improved bond rating will save the district approximately \$215,000 over the life of the bonds used to help pay for the new capital project.
