#### District Priorities

#### 2023-2024 Tax Levy

- *Allowable* Tax Cap 2023-24 = 2.2%
- <u>Actual School Tax Levy increase for 2023-24 = 1.9%</u>
- School Tax Levy will increase by \$143,084
- Total School Tax Levy will be \$7,673,829

### Factors Driving Budget Increase

- Salaries
- Rising supply and fuel costs
- Special Education Costs

#### Transportation Proposition

- State Law restricts pick-up and drop-off to 2 miles for students in grade P-8 and 3 miles for students in 9-12
- Presents a dangerous situation for many of our students
- Board Resolution to pick up and drop off all district students over ¼
  mile from their school building
- Requires voter approval and is on the ballot on May 16

### Energy Performance Contract (EPC)

- District has agreed to have more than \$2.8 million in energy savings work completed in addition to the Capital Project
- Work from EPC will pay for itself over a period of time, even without building aid
- Voter approval required to get an additional 10% in building aid on the EPC
- Proposition will be on ballot May 16
