### Superintendent's Message on behalf of the Unatego Board of Education

As I write this message in early May, the only thing certain about the 2020-2021 budget is uncertainty. Late Friday afternoon of March 13, 2020, the Otsego County Department of Health ordered all schools in the county closed for a public health emergency. On March 18, Governor Cuomo ordered all schools in New York closed for what turned out to be the rest of the academic year. During the period of time when our buildings were closed, instruction continued with teachers and support staff working from home and students learning on district-provided devices. We also continued to provide more than 1,200 meals each week to our students at no cost to their families. We are now engaged in planning how to safely reopen our buildings in the fall.

Our 2020-2021 budget is up only \$15,510 over the current school year, or about .07%. With no increase in state aid, we are requesting voters to approve an increase of 1.12% in the tax levy. Although state aid is promised to remain at 19-20 levels, the governor has reserved the right to withhold payment if revenues drop below projected levels. He has mentioned a 20% reduction in aid if the state fails to receive additional funding from the federal government. As Unatego receives more than 2/3 of our revenue from state aid, or about \$14.3 million annually, a 20% reduction in aid would result in a cut of roughly \$2.8 million! In developing the budget for the upcoming school year, the Board of Education is hoping for the best but preparing for the worst. The \$22,831,405 spending plan will allow us to continue to maintain program for our students, including AP and college courses, Robotics and other STEM offerings, as well as no-cost breakfast and lunch for all students, regardless of income. We have also identified possible spending cuts should the state reduce promised aid payments in mid-year and will do everything we can to contain costs throughout the school year.

Over the past six years, the District has worked hard to be fiscally responsible while expanding opportunities for our students. This year's proposed budget includes the appropriation of approximately \$740,000 in reserves and fund balance which we have saved for a rainy day, allowing us to maintain program while keeping the tax levy increase to a minimum and staying within the tax cap of 1.12%.

We remain committed to providing our students with a first-rate education while keeping costs to the community as low as possible. We feel that, under the current circumstances, the proposed 2020-2021 school budget does just that. Please vote (by absentee ballot only) before June 9, 2020. ### **Budget Presentation**

The development, review, and consideration of the 2020-2021 Unatego Central School budget was completed with a detailed review of the revenue and expenditure items that make up the budget. This was done within the context of the District's mission, goals, and financial policies.

We are proud to publish and disseminate budget information to our community. We welcome the opportunity to present and discuss our plans and related financial impact with all concerned parties. Interaction among interested groups consistently leads to educational improvements which become available to our students.

Our most important concern in the presentation of budget data is to provide information to our community about the District's educational programs and services for the 2020-2021 school year and how the budget supports these programs and services. The material in this document includes information that has been suggested by the Board of Education, community members, and staff. A line item budget is available online at *Unatego.org*. ### **Budget Process and Significant Change**

The budget process commenced with the development of the student enrollment forecast for the 2020-2021 school year. These forecasts predict our enrollment for next year will be about 720 students.

### **Resources to Support Operations**

The financial support for district-operated programs and services are substantially derived from state sources and the property tax. The tax levy is increasing by 1.12% for the 2020-21 school year.

This is where a majority of the heating fuel is budgeted. However, debt service (principle and interest payments) on building projects and some special items are also included.
