

2023-24 PROPOSED BUDGET Superintendent's Message on behalf of the Unatego Board of Education

District staff are prepared for significant changes beginning this spring. Phase I of the voter-approved \$27.6 million capital project will begin this summer, bringing long-needed improvements to our facilities. Work in this phase includes renovations to the auditorium, locker rooms, and hallways at the Junior-Senior High School. A separate Energy Performance Contract or EPC will add more than \$2 million in energy efficiencies to the capital project. Additional health and safety work will be completed at the Unatego Elementary School while the Bus Garage will receive a new bus lift. The capital project, which will be completed over the next several years, will also include renovations to the classrooms at the Middle and High School, as well as improvements to the athletic fields. In addition to the opportunity to vote on the 2023-24 school budget, voters will also consider a proposition to allow school transportation for children who live more than a quarter mile from their school building (see **Proposition To Transport Students from ¼ Mile from their School Building on Ballot** in this newsletter). The EPC, which will produce sufficient energy savings to pay for the improvements in under 8 years, is also on the ballot and if voter- approved, will generate an additional 10% in state building aid.

As we all know, costs of everything have increased over the past couple of years. While inflation continues to increase costs at a rate of more than 6% annually, we are pleased to have kept the budget well below the inflation rate at an increase of 1.1%, which requires an increase in the tax levy of 1.9%. This modest tax increase will allow us to continue to provide our students with an outstanding education and services in the coming year.

Administrative: The Administrative component of the budget includes expenditures for central administrative and support salaries and related costs, Board of Education expenses, legal expenses, business office expenses, and insurance.

Program: The program component of the budget includes expenses relating to instruction, including salaries, benefits, textbooks, supplies, transportation, and athletics.

Capital: The Capital component of the budget includes custodial salaries and benefits, building maintenance costs and debt service costs.

PROPOSED TAX LEVY INCREASE IS 1.9%

The proposed Tax Levy increase for our school district is 1.9% for the 2023-24 school year. The proposed budget adopted by the Board of Education results in a tax levy increase that is within the district's allowable 2.2% Tax Levy limit.

The chart below is intended to show an estimate of projected tax increases for homes of different assessed values. Actual tax rates are affected by many factors beyond the school district's control such as Assessed Values, State Equalization Rates, and STAR Exemptions. Actual tax rates will not be set until sometime in August when the state finalizes equalization rates for each of our district's seven townships. The following chart simply displays the amount of a 1.9% increase on varying levels of hypothetical assessed values at Full Market Value.

CAPITAL PROJECT UPDATE MAY 2023

We are extremely pleased to announce the first phase of our capital project will start this spring. Approved by district voters in May 2021, Phase I of the \$27.6 million building project was approved by NYSED in late January and The Board of Education has awarded bids to contractors. Phase I includes work at the Unatego Elementary School, the District Transportation Center, and primarily at the Junior-Senior High School.

Work at the Elementary School consists of minor plumbing, electrical, and safety upgrades, installation of a new PA, clock, and fire alarm system, and a monitoring station for wastewater to bring our septic system up to new standards. The focus of construction at the bus garage in Phase I is to replace the 1951 bus lift with a new state-of-the-art lift.

Most of the rest of the project is aimed at the Junior-Senior High School. This June, we will start renovations of the HS auditorium and the boys' and girls' locker rooms. Additional work in Phase I will include a new fire alarm system, roofing replacement, hallway renovations, and asbestos abatement. As the project progresses, additional work will be completed in classroom areas of the 1968 building. Athletic fields will receive much-needed improvements and the HS auditorium and classroom spaces will be air conditioned by the end of the project as well. Some of the original energy saving components have been moved from the project into an Energy Performance Contract or EPC to offset increasing construction costs.

Following an Energy Audit funded through a NYSERDA grant, much of the energy efficiencies recommended in the original project have been removed included in an Energy Performance Contract, or EPC, which guarantees the energy savings from the improvements will pay for the cost (See **Unatego Embarks on Energy Performance Contract (EPC)** elsewhere in this newsletter.

Once we get through what's left of winter, we are excited to start this amazing project to modernize our facilities, improve safety, and conserve energy. The anticipated completion of the project is September 2025.

PROPOSITION TO TRANSPORT STUDENTS FROM ¼ MILE FROM THEIR SCHOOL BUILDING ON BALLOT



Currently, in accordance with NYS Law, Unatego is only required to transport students in K-8 who live more than two miles from their school building of attendance and more than three miles for students in grades 9-12. Student safety has long been a major focus at Unatego, and it is well-known that students are safest going to and from school on a bus, driven by highly qualified transportation professionals. In the interest of student safety, the Board of Education recently voted to allow any student living more than ¼ mile from their school to be picked up and dropped off by school bus. However, NYS Law also requires voter approval of such a change. On May 16, 2023, in addition to considering the district budget and electing three school board members, voters will also be asked to vote on the proposition to change

Voting Qualifications

For the May 16, 2023 Budget Referendum

In order to vote, a person must fulfill all of the following requirements:

- 1. Be a citizen of the United States.
- 2. Be at least 18 years of age.
- Be a resident within the district for a period of at least 30 days preceding the meeting at which he/ she offers to vote.

UNATEGO EMBARKS ON ENERGY PERFORMANCE CONTRACT (EPC)

As part of our ongoing effort to provide updates to our aging infrastructure and to reduce our carbon footprint, the District has agreed to have energy work done that is guaranteed to pay for itself over a period of time. This project, in conjunction with the ongoing Capital Project, will



provide energy savings that will pay for the improvements over a period of 18 years and will require no local contribution from taxpayers.

The scope of the EPC includes work at the Jr-Sr High School consisting of LED lighting, high efficiency propane boilers, digital HVAC controls, and building envelope improvements resulting in approximately \$159,000 annual savings (without building aid) and an 18-year payback period. With state building aid, the District will see a surplus amounting to \$124,226 per year and a simple payback period of 7.5 years.

This project dramatically reduces our dependency on fossil fuels. The EPC will save 179 Metric Tons of CO2 based on electric emissions and 372 Metric Tons of CO2 based fossil fuel emissions. This is equivalent to removing 143 cars from the road each year. This carbon reduction is equivalent to installing 4.55 acres of solar panels. Energy efficiency is not only good for the environment but saves the district money and acts a hedge against volatile future energy costs.

Although the Board of Education has determined that this project makes sense without additional aid, they have decided to ask for voter approval which if given, will result in an additional 10% in state aid and provide even more savings to district taxpayers.

On May 17, 2023, in addition to electing board members and voting on the District budget, there will be referendum on the ballot asking voters to approve the EPC, thereby generating an additional 10% in building aid.
